

Emissions reduction targets

Due to above data collected for a period of under a year, we will set our targets upon completion of a full year cycle. In order to continue our progress to achieving Net Zero, we have adopted the following carbon reduction targets.

We project that carbon emissions will decrease over the next five years to 3 tCO2e by 2028. This is a reduction of 25%.

BPP's environmental management system is certified by ISO 14001. Over the last 3 years we have reduced emissions by:

- adopting hybrid working whereby BPP staff have reduced their business travel
- introducing Sharepoint to enable digital working and meeting thereby reducing paper, printing, waste

Upon gathering more data BPP will in future be reporting carbon reduction initiatives addressing emissions across scopes 1, 2 and 3 via comparison graph.

Declaration and Sign Off

This Carbon Reduction Plan has been completed in accordance with PPN 06/21 and associated guidance and reporting standard for Carbon Reduction Plans. It is to be noted that this Plan is in its infancy with base year 2023 based on data gathered for less than a year. This Plan is being issued to demonstrate BPP's commitment to Carbon Reduction.
