BPP does not have emissions to report on Scope 1 and 2 for the following reasons:

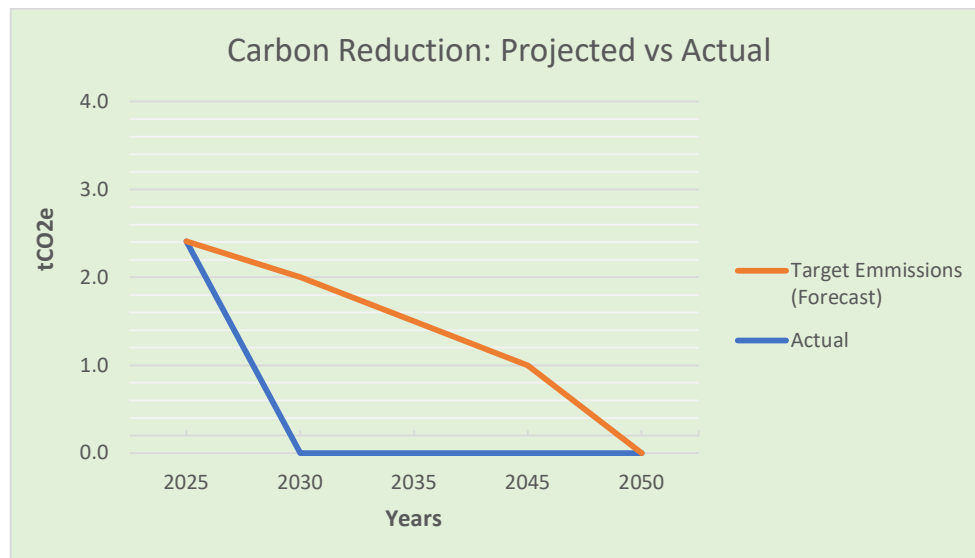
- Scope 1 - BPP does not own nor control vehicles/processes thereby does not produce emissions from combustion nor chemical production.
- Scope 2 – BPP hires serviced offices whereby energy consumption is under the provider's responsibility.

Emissions reduction targets

In order to continue our progress to achieving Net Zero, we have adopted the following carbon reduction targets.

We project that carbon emissions will decrease over the next 5 years to 1.8 tCO₂e by 2030. This would be a reduction of 45% from baseline year.

Progress against these targets can be seen in the graph below:



Carbon Reduction Projects

The following environmental management measures and projects have been completed or implemented since the 2023 baseline. The carbon emission reduction achieved by these schemes equate to 2.41tCO₂e in this reporting period (Oct 2025), a 60% reduction against the 2023 baseline and the measures will continue to be in effect when performing our services:

- BPP's environmental management system is certified by ISO 14001.
- adopting hybrid working whereby BPP staff have reduced their business travel
- Adopting Sharepoint to enable digital working and meeting thereby reducing paper, printing, waste.

Upon gathering more data BPP will in future be reporting carbon reduction initiatives addressing emissions across scopes 1, 2 and 3 via comparison graph.

Declaration and Sign Off

This Carbon Reduction Plan has been completed in accordance with PPN 06/21 and associated guidance and reporting standard for Carbon Reduction Plans.

Emissions have been reported and recorded in accordance with the published reporting standard for Carbon Reduction Plans and the GHG Reporting Protocol corporate standard¹ and uses the appropriate Government emission conversion factors for greenhouse gas company reporting².

Scope 1 and Scope 2 emissions have been reported in accordance with SECR (Streamlined Energy & Carbon Reporting) requirements, and the required subset of Scope 3 emissions have been reported in accordance with the published reporting standard for Carbon Reduction Plans and the Corporate Value Chain (Scope 3) Standard³.
